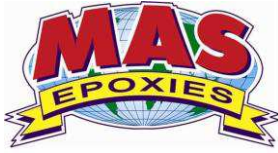

SECTION 4: FIRST-AID MEASURES

DESCRIPTION OF NESSEARY FIRST-AID MEASURES:

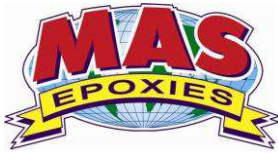

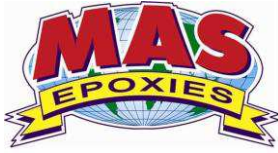
